MATH 0332 Course Description: Math 0332 is to be taken concurrently with MATH 1332. Background topics necessary for a student to successfully complete MATH 1332 will be covered with an emphasis on integers, percentages, graphing, fractions, exponents, radicals, statistics, and geometry.

MATH 0332 Prerequisite: Maximum score of 349 on the TSIA without an ABE score, or a successful completion of NCBM 0105.

MATH 1332 Course Description: Intended for Non STEM (Science, Technology, Engineering, and Mathematics) majors. Topics include introductory treatments of sets and logic, financial mathematics, probability and statistics with appropriate applications. Number sense, proportional reasoning, estimation, technology, and communication should be embedded throughout the course. Additional topics may be covered.

MATH 1332 Prerequisite: Minimum score of 350 on the TSIA, TSI-exempt status, or a successful completion with a grade of ' $C$ ' or better in MATH 0337.

Course Evaluation: There will be departmental final exam questions given by all instructors.
Attendance/Student Engagement Policy: Attendance and effort are the most important activities for success in this course. The student will be allowed to miss twenty percent ( $20 \%$ ) of class assignments for the semester, for any reason. Course Modality: Flipped/Face-to-Face ~ In this course, classes will be held face-to-face, twice a week in a classroom, specifically Tuesdays and Thursdays in Room M124. In addition, students will be responsible for watching pre-recorded lectures prior to each class period. Class meetings will be used for remediation, review, and homework assistance. During class meetings, the instructor and students will be expected to practice social distancing and appropriate hygiene and to observe all SPC policies regarding COVID-19.

Supplies: You will need pencils, notebook paper, and a folder or binder. A non-graphing scientific calculator (such as a TI-30) is required. Calculators on cell phones or other electronic devices are not allowed.

You will need access to a working computer with reliable internet access. All homework will be submitted on Blackboard. It is permissible to submit photos of your work but creating pdfs of your homework and uploading those is the best way to ensure a clear, easy to read/grade document. There are several methods/apps for doing this. A couple of popular apps are CamScanner and Genius Scan.

Blackboard: Information and resources pertaining to this course are available on Blackboard. The syllabus, instructor contact information, and all course resources are stored there. Assignments and due dates, as well as, exam dates are posted on the Blackboard calendar. I'll be posting your grades in the gradebook on Blackboard so that is where you can see what your grade is in the course at any time. You should get into the habit of checking Blackboard daily for pertinent information.
