A tax rate of \$0.306843 per \$100 valuation has been proposed by the governing body of SOUTH PLAINS JR COLLEGE.

The no-new-revenue tax rate is the tax rate for the 2022 tax year that will raise the same amount of property tax revenue for SOUTH PLAINS JR COLLEGE from the same properties in both the 2021 tax year and the 2022 tax year.

The voter-approval rate is the highest tax rate that SOUTH PLAINS JR COLLEGE may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that SOUTH PLAINS JR COLLEGE is proposing to increase property taxes for the 2022 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON Tuesday, August 23, 2022, at 8:00 a.m. in the Board of Regents Meeting Room, Administration Bldg., 1401 S. College Ave., Levelland

The proposed tax rate is not greater than the voter-approval tax rate. As a result, SOUTH PLAINS JR COLLEGE is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the of SOUTH PLAINS JR COLLEGE at their offices or by attending the public hearing mentioned above.
