# South Plains College Intro to Mass Comm Fall 2021 Syllabus COMM 1307.201

**Credit**: 3 semesters hours

**Course Description**: Survey of basic content and structural elements of mass media and their functions and influences on society.

**Recommended Supplies:** I recommend that you take notes when you read, watch, and/or study course modules. You will need a spiral notebook or notebook paper for that.

**Recommended Textbook**: Media & Culture Mass Communication in a Digital Age by Campbell, Martin and Fabos, 11th Edition 978-1-319-05851-7 There is a copy of the 9<sup>th</sup> edition on reserve at the circulation desk at both the Levelland and Reese campus libraries.

**Technical Requirements:** You **must** have or have access to a smart phone with a camera for your TikTok assignment this semester. It is also in your best interest to

have reliable access to Internet service and a computer so that you can send and receive e-mail, access lectures, submit assignments, participate in Collaborate sessions, and take exams. Several students who have tried to complete this course relying on a smartphone only, have not succeeded.

#### Points are earned as follows:

# **Instructors Expectations of the Student**

· You will be expected to log into the Blackboard course each week to be aware of possible announcements/reminders and to pace your progress in the course.

· Higher institutions recommend that students plan to spend 2 hours of outside study for every 1 hour of in class time. For a 3 credit-hour, face-to-face course that means a total time investment of nine hours per week, or 135 hours per semester, in a 15-week course. Expectations for time investment are no less rigorous for online courses at SPC. According to this guideline, you should expect to invest 9 hours per week in this course, during a spring or fall semester; more in a summer course.

### **Lost/Corrupt/Disappeared Files**

You must keep/save a copy of every project/assignment on an external disk or personal computer. In the event of any kind of failure (e.g., Blackboard server crash or virus infection, students own computer crashes, loss of files in cyberspace, etc.) or any contradictions/problems, I may/will request you to resubmit the files. In other words, if you submit a document to me, and I do not receive it (lost in cyberspace) or it is corrupted when I open it, you need to resend it to me, corrected, with little or no "downtime" in regard to the timeline for submission.

#### Missed Work

Please do NOT assume that I will contact you to tell you about missed work. Course materials will be available on Blackboard so you can keep track of all materials week by week. You can expect a new class module each week.

The assignments in this class will be deadline driven. You must keep track of deadlines and submit work when it is due.

Do NOT assume that I will move deadlines for you unless you contact me and offer very good and documentable reasons why you cannot meet deadlines that are in place.

If you do not participate in class, in any form, for a minimum of 3 weeks without any communication, and you are earning a solid "F", you may be administratively withdrawn from the class. You may contact me by phone, email, or Collaborate. But you must stay in contact with me about reasons for absence.

Students are officially enrolled in all courses for which they pay tuition and fees at the time of registration. Should a student, for any reason, delay in reporting to a class after official enrollment, absences will be attributed to the student from the first class meeting.

Students who enroll in a course but have "Never Attended" by the official census date, as reported by the faculty member, will be administratively dropped by the Office of Admissions and Records. A student who does not meet the attendance requirements of a class as stated in the course syllabus and does not officially withdraw from that course by the official census date of the semester, may be administratively withdrawn from that course and receive a grade of "X" or "F" as determined by the instructor. Instructors are responsible for clearly stating their administrative drop policy in the course syllabus, and it is the student's responsibility to be aware of that policy.

It is the student's responsibility to verify administrative drops for excessive absences through MySPC using his or her student online account. If it is determined that a student is awarded financial aid for a class or classes in which the student never attended or participated, the financial aid award will be adjusted in accordance with the classes in which the student did attend/participate and the student will owe any balance resulting from the adjustment.

<u>Deadlines</u>- ALL projects will have deadlines. You need to get used to deadlines that exist in the working world. Late assignments may or may not be accepted depending on the assignment and the reasons for missing the deadlines. In the event that you miss an exam, you must notify me within 48 hours about why. You may or may not be able to "make up" the missed exam. If you miss an exam due to COVID-19, you will take the exam the day you return.
